TEST DRIVE – SUPPLEMENTARY AGREEMENT TO THE APPLICATION FORM

By signing the application form and this supplementary agreement, we confirm that we will participate at the Test Drive. A regular booth space at The smarter E Europe 2025 must already be booked. Notwithstanding the services, obligations and prices specified in the application form and the general terms and conditions of participation, the following applies to participation in the Test Drive:

- The organizers of Power2Drive Europe 2025 allow the participants to offer on-road test drives of electric vehicles, starting from parking lot and passing through a pre-determined exit onto the road.
- The exhibitor must sign a liability agreement in order to make use of the Test Drive area provided by the organizer. In the agreement, the exhibitor shall fill in a maximum liability sum which is to be defined according to the value of the vehicles made available. The liability agreement must include the name and contact details of the contact person on site and must be submitted no later than two weeks before the start of the exhibition.
- The exhibitor must also ensure that visitors sign a liability agreement before beginning their test drive. The liability agreement shall be issued by the exhibitor both in German and in English and must submitted to the organizer as a blank form to be filled in.
- The test vehicles must be registered with the organizer (manufacturer and license plate number) and approved for road traffic no later than one month before the start of the exhibition.
- The vehicles must be available for the Test Drive for the entire duration of the exhibition.
- The test drives are to be organized entirely independently by the participating exhibitors.
- The outdoor area takes place in principle in any weather. The organizer is entitled to cancel the Outdoor Area in case of extreme weather conditions, especially storm, hail, heavy rain or snowfall, at its own discretion. In this case claims for damages are excluded.

These services are included:

- Entry in the exhibitor list with the designation "Participant Test Drive"
- Parking spots for the vehicles
- Charging facilities for the vehicles
- Space for advertising materials (pop-up tent, banners etc. – only by arrangement, possible up to one month before the start of the exhibition at the latest)
- Booth surveillance outside the exhibition opening hours (from Tuesday, May 6, 2025 in the evening to Friday, May 9, 2025 in the morning)
- Supervision of the check-in by supervisory staff (verification of the authorization of use by the exhibitor as well as the driving license and the signed disclaimer of the test driver)

The total number of vehicles in the Test Drive is limited. Maximum of three vehicles per exhibitor. Conditions for additional vehicles on request.
