

SUPPLEMENTARY AGREEMENT TO THE APPLICATION FORM FOR THE eCAR TEST DRIVE

Congratulations on taking the next step and offering our visitors the opportunity to experience your product firsthand in an eCar Test Drive. By signing the application form The smarter E Europe 2024 and this supplementary agreement, you confirm your participation. A regular booth space at The smarter E Europe 2024 needs to be booked as well. Notwithstanding the services, obligations and prices specified in the application form and the general terms and conditions of participation, the following applies to participation in the Test Drive:

- The organizers of Power2Drive Europe 2024 allow the exhibitors to offer on-road test drives of electric vehicles, starting from parking lot and passing through a pre-determined exit onto the road.
- The exhibitor must sign a disclaimer of liability in order to make use of the test drive area provided by the organizer.
- In the agreement, the exhibitor shall fill in a maximum liability sum which is to be defined according to the value of the vehicles made available.
- The outdoor area takes place in principle in any weather. The organizer is entitled to cancel the outdoor area in case of extreme weather conditions, especially storm, hail, heavy rain or snowfall, at its own discretion. In this case claims for damages are excluded.

The exhibitor must ensure that visitors sign a liability agreement before beginning their test drive. The liability agreement shall be issued by the exhibitor both in German and in English and submitted to the organizer as a blank form to be filled in. The test vehicles must be registered with the organizer (vehicle manufacturer and license plate number) and be approved for use in traffic.

The vehicles must be available for the Test Drive for the entire duration of the exhibition. The test drives are to be organized entirely independently by the participating exhibitors. During the exhibition, the the Check-In area will be staffed by supervisors (who will check that the exhibitor is entitled to use the Test Drive area and that test drivers are licensed to drive and have signed a disclaimer of liability). A night guard will be present on Wednesday and Thursday night.

These services are included:

- Entry in the regular exhibitor list with the designation "Participant in the eCar Test Drive"

At the eCar Test Drive starting point (parking lot):

- Parking spots for the vehicles
- Charging facilities for the vehicles
- Space for advertising materials (pop-up tent, banners etc.) upon consultation

The total number of vehicles in the Test Drive is limited.

Maximum of three vehicles per exhibitor.
